**UNAUDITED OPERATION DATA FOR FEBRUARY 2025**

The board of directors (the “**Board**”) of Sunac China Holdings Limited (the “**Company**”) announces certain unaudited operation data of the Company, its subsidiaries and joint ventures and associates (the “**Group**”) for February 2025 as follows:

In February 2025, the Group achieved contracted sales value amounted to approximately RMB1.80 billion, and contracted sales area amounted to approximately 152 thousand sq.m., with contracted average selling price of approximately RMB11,840 per sq.m..

As at the end of February 2025, the Group achieved contracted sales value amounted to approximately RMB8.64 billion, and contracted sales area amounted to approximately 264 thousand sq.m., with contracted average selling price of approximately RMB32,730 per sq.m..
